DELETE Paragraph 7.5.1 of Spec Code 32831d.12 in its entirety and REPLACE with the following:

**7.5.1 Rear suspension shall be Hendrickson HMX series**

DELETE Paragraph **7.6** of Spec Code 328131d.12 in its entirety and

REPLACE with the following:

**7.6 OMIT**

DELETE Paragraph **11.1** of Spec Code 32831d.12 in its entirety and

REPLACE with the following:

**11.1 Provide an automatic transmission, ALLISON MD3500-RDDS-5speed, compatible with all other drive train components. Provide synthetic oil.**

DELETE Paragraph 17.1 of Spec Code 32831d.12 in its entirety and

REPLACE with the following:

**17.1.1 Provide fire extinguisher (2 ½ lbs.), reflective triangle kit both cab mounted.**

DELETE Paragraph **17.3** of Spec Code 32831d.12 in its entirety and

REPLACE with the following:

**17.3 Provide an environmental spill kit, mounted on the side of the unit. (Minimum – 5 Gallon Universal Spill Kit, (2) Containment Socks, (12) Absorbent Pads, (1) 5-Gallon Bucket w/lid, (1) pair rubber gloves, (1) 5lb bag of UltraSorb, (1) 35 Gallon Ultra Trash Bag)**

Question: Page 5 of 21, 1.8.7: Delete the Local Business Entity from this bid.

As we are one of a few heavy duty truck dealers in the region that a provided heavy truck bids to the city in the past, only one has a LBE Certification. This only one truck dealer with a LBE Cert. has a tremendous advantage considering the basis of award is the total bid, less inspections. The means with the current LBE only one bidder would have a 5% advantage of four (4) different body builders, plow and plow equipment with an est. value of \$250,000.00. None of the specified body builders (subcontractors) are within the city limits. With the present LBE language "...I certify, that if awarded this contract..." and "will perform the majority of the work under this contract within the geographic limits..." the LBE cannot be meet. Thus we request the LBE be deleted from this bid.

Answer: Paragraph 1.8.7 shall remain as is.
